Debit & Credit Card Fraud Monitoring

Alabama Teachers would like to send you a friendly reminder that your debit and credit cards are monitored for fraudulent activity 24 hours a day, 7 days a week. We work diligently to ensure that you, our members, always feel safe and secure when using your debit and credit cards. We also encourage you to notify us if you are planning on traveling outside of your normal area of residence. This will help to protect your debit or credit card from being blocked by our fraud department while you are traveling.

If you receive a message regarding activity on your account or you are traveling within the United States and your card is being declined you may contact our Fraud Alert Management team at 888-241-2440 for debit card usage or 800-437-9392 for credit card usage. If you are traveling outside of the United States you may contact Fraud Alert Management at 909-941-1034 for debit card usage or 727-227-2447 for credit card usage.
